

CodeCuriosity Terms of Service

Last updated: 1st Aug, 2017

Please read these Terms of Service ("Terms", "Terms of Service") carefully before using the CodeCuriosity application (the "Service", "CodeCuriosity") operated by Josh Software ("us", "we", or "our").

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all registered users and others who access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you may not access the Service.

Termination

We may terminate or suspend access to our Service immediately, without prior notice or liability, for any reason whatsoever, including without limitation if you breach the Terms.

All provisions of the Terms which by their nature should survive termination shall survive termination, including, without limitation, ownership provisions, warranty disclaimers, indemnity and limitations of liability.

Subscription

Some parts of the Service are billed on a subscription basis ("Subscription(s)"). You will be billed in advance on a recurring monthly basis as per the plans mentioned below. All users registered on CodeCuriosity before 1st Aug, 2017 are by default subscribed to the Free plan.

"Earned Points" are earned from open-source contribution after registration on CodeCuriosity. "Royalty Points" are awarded once at the time of registration for past contributions to open-source.

1. Free Plan

- Redemption of points will be done at a ratio of 20 points to 1 USD.
- In any given month, you can redeem a maximum of 400 Royalty points, worth 20 USD.
- Redemption requests can be made only if you are registered on Service for at least 3 months and are also registered on Github for at least 6 months.

2. Individual Plan

- The user must be a registered user on Code Curiosity via Github.
- The registered user subscribing to this plan will be charged **5 USD on a monthly basis** from the date of subscription.
- All Earned Points will be moved into Royalty Points.
- Redemption of points will be done at a ratio of 10 points to 1 USD.
- In any given month, you can redeem a maximum of 500 Royalty points, worth 50 USD.
- Redemption requests can be made immediately after subscribing to this plan.
- Individual gets a custom CodeCuriosity badge for rewarding open-source.

3. Company

- The company must be a registered user on Code Curiosity via Github.
- The registered user subscribing to this plan will be charged **250 USD on a monthly basis** from the date of subscription.

- Company can request the Service to reward a maximum of 100 USD per month to users who contribute to open-source repositories they own.
- Company can change the judging criteria for contributions to the repositories they own.
- Company logo and website link will be promoted on the Service homepage and in every mailer that is sent to users.
- Company gets a custom CodeCuriosity badge for rewarding open-source.

Should you decide to **downgrade the plan from Individual to Free** plan

- All your Earned Points would be moved into Royalty Points.
- Redemption of points will be done at a ratio of 20 points to 1 USD.
- In any given month, you can redeem a maximum of 400 Royalty points, worth 20 USD.
- Redemption requests can be made only if you are registered on Service for at least 3 months and are also registered on Github for at least 6 months.

Account Deletion

Should a registered user choose to delete their account from CodeCuriosity, there will be no refund of any subscription paid till that time.

Content

Our Service accesses your public open source contributions on Github. You are responsible for the authenticity of the code and any plagiarism is your responsibility.
